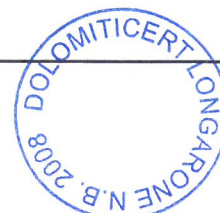

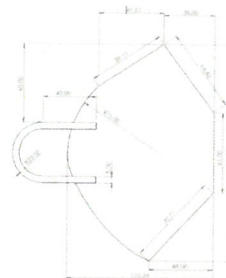

PPE description and notes:

Valveless and disposable filtering half mask classified as FFP2 NR according to its filtering efficiency and its maximum total inward leakage. Filtering half masks are intended to provide adequate sealing on the face of the wearer against the ambient atmosphere when the skin is dry or moist and when the head is moved. This type of device covers the nose, the mouth and the chin of the user and consists entirely or substantially of filter material or comprises a facepiece in which the main filter(s) form an inseparable part of the device. Particle filtering half masks are designed to protect against both solid and liquid aerosols.

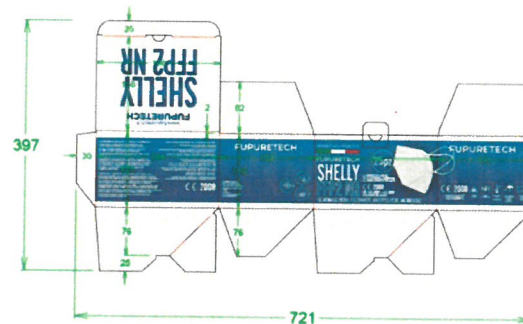

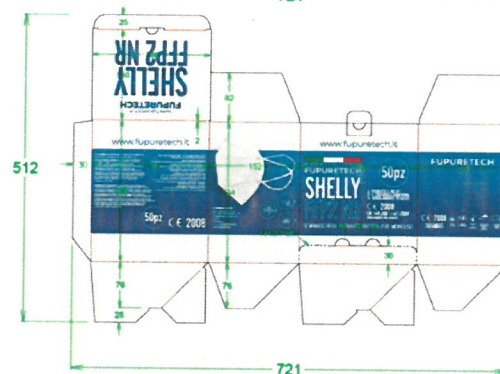
